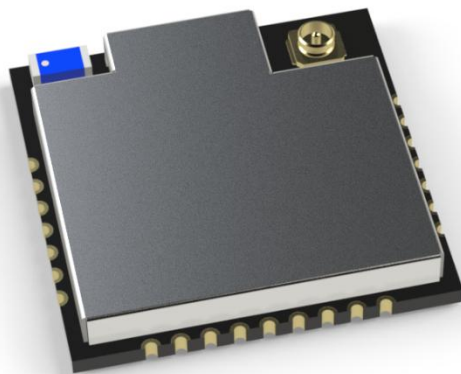

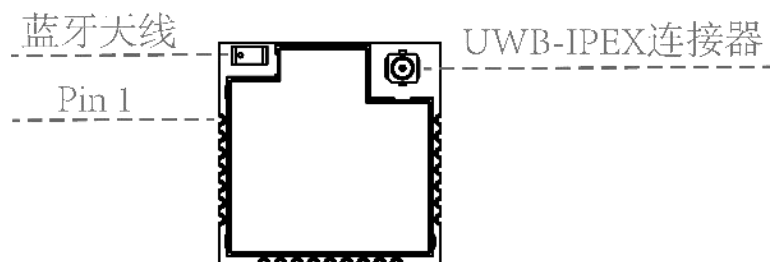


图 1: T06 构造示意图

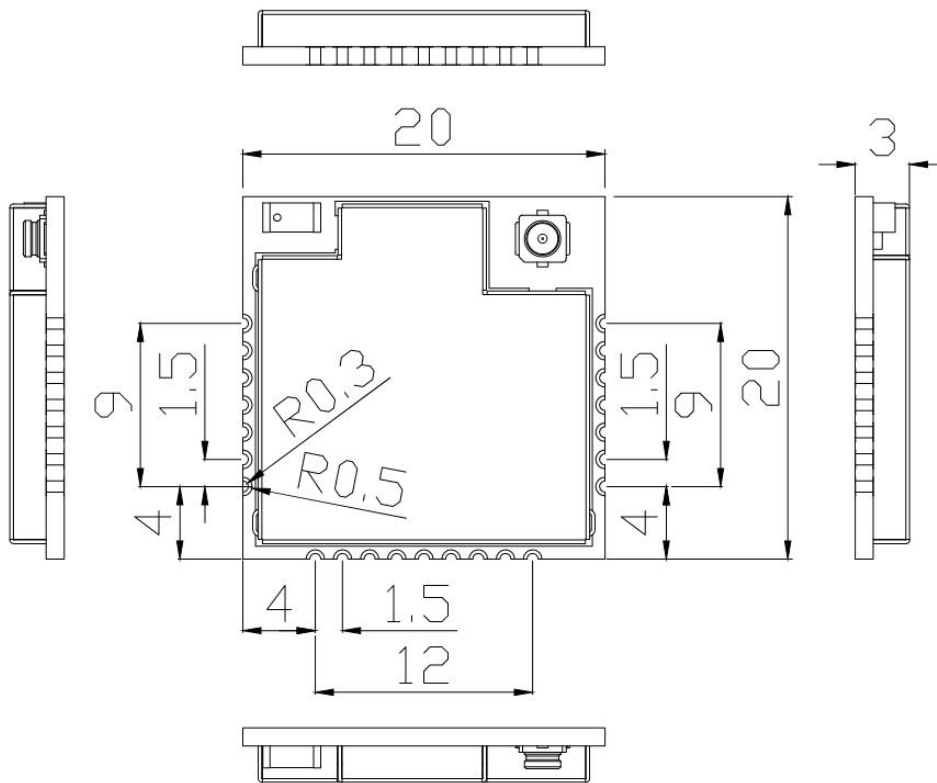


图 2: T06 尺寸图 单位: mm
